13	Introduction	NJ introduced the second part of the meeting the AGM of the Association.
14	Minutes of the AGM held 16 th January 2023	NJ presented the minutes from the last AGM.
15	Minutes of EGM held 22 nd May 2023	NJ presented minutes from the EGM With no matters arising from the AGM minutes or EGM minutes he requested members to approve both sets of minutes. They were approved unanimously.
16	Highlights 2023 and looking forward to the future	JW presented a review of all the year's highlights and outlined successful Kent players had been during the year culminating with 2 World Champions, 11 National Champions and 2 National team Champions .
		NJ presented his vision for the future and challenged everyone at the meeting to think about 1 thing they could do to open up their club or venue so that everyone has access to the sport of tennis. He hoped that the next year's AGM we could report on what clubs had achieved.



17	Annual Review 2023	NJ pointed out the Annual Review this year was digital only and he hoped that members had seen the review on the website. He thanked Phil Lynch for putting together all the information for the results section. He asked members to approve the Annual Review 2023. The Annual Review was approved unanimously.
18	Financial Report	NJ presented financial report for the 15 month period from 1st October 2022 to 31st December 2023. He outlined that despite setting a deficit budget, the year end was surplus of £22k. This is despite continuing increase in costs such as the increase in staffing hours /personnel. The main reason for the surplus is due to the large increase in sponsorship to £112k. Big thanks go to Keith Gill for his hard work in achieving this level of sponsorship. The Charity is registered for Gift Aid which may result in further donations. The organisation is financially sound with good levels of reserves which has enabled the organisation to fund key initiatives such as Walking Tennis. Loans to clubs has been the highest ever, with the maximum loan amount been increased from £10k to £25k. Another deficit budget has been set for 2024 and this will be closely monitored. JR raised the use of the £210k loan relating to Bromley Tennis Centre (BTC) and how important the continued success of the centre was for tennis in Kent. He outlined that when he was on the Board, that Kent Tennis agreed to pay for the replacement of the courts (£75k but his understanding is that the organisation cannot support a commercial organisation. NJ explained that the £210k was lent to Kent Tennis by the LTA and no actions have been taken by the LTA to recover for payment of the loan and that the period to repay comes to an end in September, so only 1 instalment of £7k could be claimed. BTC is currently owned by ULT who runs the school and the centre is operated by Virtus who have responsibility for the maintenance of the centre. Trustees have debated and agreed to pay the refurbishment of the courts but will not utilise the £130k. Negotiations are currently underway to develop a sinking fund for the centre and legal responsibility for maintenance will sit with Virtus. The £170k asset on the balance sheet will be revalued NJ requested for members to approve the financial report. Approved unanimously.
